

### Location

Hereford is an historic cathedral city on the River Wye, located in the English county of Herefordshire near the Welsh border. It's famous for its cathedral, which houses the 800-year-old medieval map known as the Mappa Mundi and a unique Chained Library The city is also known for its cider-making heritage, its breed of cattle, and attractions like the Black and White House Museum

### **Situation**

The property is located in a prominent corner location of High Street which links the Cathedral Quarter to Maylord and Old Market. The area includes major multiples such as Marks & Spencer, Boots, Superdrug Vision Express, F Hinds etc

# **Description**

The property is not listed but within a conservation area. It provides open plan ground floor sales with ancillary on first. The basement has been voided to maximise ground floor sales whilst the second and third floors are unused due to distance of travel and subject to a photographic record of condition for non decoration purposes. Significant works were carried out in 2011 Involving replacement of the main pitched and flat roofs, new dormer windows and ornate frames.

### **Lease Terms**

The entire property is let to The Cornish Bakery Shops Limited for a term of ten years from 15<sup>th</sup> April 2025 on full repairing and insuring terms at an initial rent of £50,000 per annum exclusive commencing 15<sup>th</sup> April 2025. There is a tenant only break clause on 15<sup>th</sup> April 2031 subject to written notice 6 months prior. The tenant spent in the region of £300,000 fitting out and opened this summer.

### Covenant

The Cornish Bakery Shops Limited have consistently grown in stores, turnover, profitability, profits and Net worth since Covid. They currently trade out of 63 stores primarily in upmarket tourist towns.

For the year ending 30<sup>th</sup> May 2024 they had a turnover of £29,357,900 (23: £23,671,769), Post tax profit £869,095 (£1,069,807). Net Assets £5,250,368 (£4,858,119)



# Potential to convert upper parts

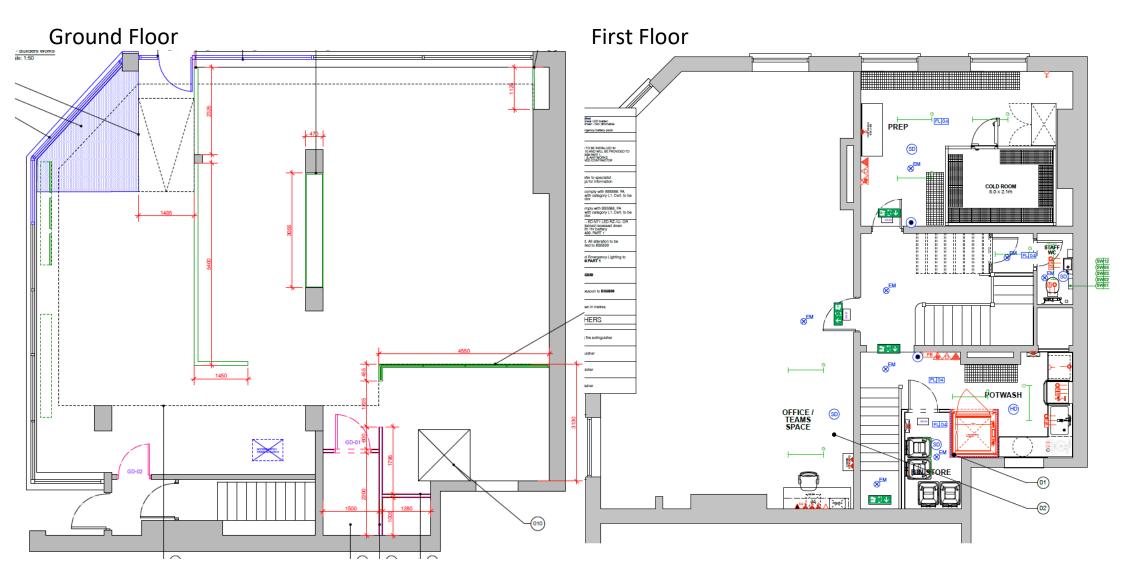
