


Former Brydian Cards Unit 10a Gore Cross Business Park, Bridport, Dorset, DT6 3UX

Gore Cross is a modern industrial estate situated at the northern end of Bridport fronting the A3066 Beaminster Road, with most of the buildings constructed post 2000 with decent access and estate roads.


Directions

From the East Road roundabout and junction of the A3066 and A35 simply follow the road north towards Beaminster. After approximately 2 miles and just after passing Colfax School on the left you come to the Gore Cross roundabout. Take the first right after Haydon Vets and the property is on the right.

Location

Bridport is a former rope making town with a thriving arts scene and a comprehensive range of shops, public houses and restaurants. The World Heritage Jurassic Coastline lies nearby at West Bay whilst sporting, walking and riding opportunities abound within the area. Dorchester lies just a short distance away by car, providing Bridport with an excellent range of cultural, recreational and shopping facilities. The region is well known for both its publicly and privately funded schooling whilst transport links are good with a mainline station at Dorchester and road links along the A35.
